

# WaterSense Labeled Toilet Rebate Application

## Multi-Family/Commercial January through December 2024

### **Rebate Availability**

Rebates are available only for EXISTING multi-family or commercial buildings located in Davis, Morgan, Summit or Weber Counties. Weber Basin Water Conservancy District (WBWCD) rebate program may be subject to change or modification at any time. Replacement toilet must be new, must be purchased and installed prior to submitting a rebate application and must have been purchased and installed in 2024. Applications must include all information requested. Failure to provide this information may result in the delay or denial of the rebate. **Multi-family/Commercial rebates must be pre-approved by WBWCD**.

### **Rebate Qualification**

This program offers a rebate for the replacement of older (pre-1994) model toilets with a WaterSense labeled low flow or high efficiency toilet. A list of toilets which qualify for the rebate can be found on the EPA's WaterSense website: <a href="http://www.epa.gov/watersense">http://www.epa.gov/watersense</a>. Although due to national plumbing codes, all toilets purchased today are 1.6 gal. flush or less. This program will run through 2024 or until funds are depleted, whichever occurs first. ## **Application Instructions:**

- 1. For Commercial and Multi-Family units, **pre-approval is needed prior to purchasing and installing qualified toilets**. Request a pre-approval by calling David at (801)-771-1677. If needed a meeting can be scheduled to discuss large quantities of toilets. Pre-approval will ensure funding is still available and allow the District to keep better track of total funding requested for larger installation projects. **Applications not pre-approved will be denied**.
- 2. Purchase and install qualified WaterSense labeled toilets. Submit the approved application and all supporting documentation in the following checklist:
  - □ Dated Sales Receipt or invoice which clearly details the following:
  - □ Retailer/Contractor name and address
  - □ Item number/model of the WaterSense Labeled toilet(s)
  - Signed application with all the information provided
- 3. Contractors may do the application for property owner/manager, but rebate checks will only be issued to property owners.
- **4.** Review and sign the application.
- 5. For tax reasons, the District requires W-9 tax forms attached or we will be required to withdraw taxes from the rebate amount. Please call our office if you have questions about this form. Any payment that exceeds \$599 the w-9 form is required.
- 6. The entire completed application should be scanned and emailed as a pdf file to <u>drice@weberbasin.gov</u>
- 7. If email isn't an option, you may mail the application and supporting materials to:

Allow up to eight (8) weeks from receipt of complete application submission to receive your rebate.
